**Conditions of Agreement**

- You must be a resident, community group, or non-profit organization of the City of Greer to participate in The Neighborhood Tool Shed Program (Herein referred to as the "Program").
- Proof of residency or utilities required.
- Any individual with an outstanding obligation or debt to the Program must resolve that obligation before being eligible to participate in the Program. Refusal to resolve existing Program obligations will result in the individual/group being declared ineligible to participate in the Program and may not borrow tools from the Tool Shed with the understanding that City may add balance as a miscellaneous bill.
- The Waiver of Liability Form must be signed before any tools can be borrowed.
- Read and agree with statement about returning tools in same condition as borrowed.
- Read and agree with statement about proper use of tools or equipment.
- Read and agree with statement about fees for damaging and/or not returning tools/equipment.

I, the undersigned, certify that the above information is correct and that my application is true and complete to the best of my knowledge. I understand that any false or incorrect information may be grounds for rejection of my application and consequently prohibit my participation in The Neighborhood Tool Shed Program. By signing this application, I acknowledge and fully agree with the rules, regulations, restrictions, and conditions of the Program.

**Neighborhood Tool Shed Lending Guidelines:**

- ONLY City of Greer residents, community groups, or non-profit organizations may borrow these tools, for non-commercial use, **FREE** of charge!
- Check out up to three (3) tools or pieces of equipment. (More with prior arrangements)
- Keep most tools for up to three (3) days (With prior arrangements, the tool or tools may be kept for up to seven (7) days.)
- **There is a late fee of \$5.00 for each late tool for each day the tool is late.**
- Tools must be cleaned and returned to the Tool Shed during its hours of operation.
- Equipment/tools returned in unclean or broken condition may result in the user not being allowed to borrow tools and/or equipment from the Neighborhood Tool Shed in the future. A \$5 cleaning fee will be charged.
- Borrower is responsible for any injury to self or others, or damage to his/her property or the property of others occurring from the use of tools or projects from the Tool Shed.
- Borrower is responsible for the use of tools by others/third parties.

**WAIVER, RELEASE AND INDEMNIFICATION AGREEMENT FOR USE OF EQUIPMENT AND TOOLS

In consideration for being allowed to use the equipment and tools from the City of Greer's Neighborhood Tool Shed, I hereby waive, release, acquit and forever discharge the City of Greer and its agents, servants and employees from all claims, actions, claims for relief, demands, rights, damages, costs, expenses (including attorney's fees), restitution and compensation, whether arising in equity, law or otherwise, for myself and anyone claiming through me, or any third party, which exist now or which may hereafter accrue as a result of or in connection with my possession or use of any equipment or tools from The Neighborhood Shed Program, including, but not limited to, any and all injuries, personal injuries, death and property damage and the consequences thereof, whether to myself or a third person, arising out of any cause whatsoever.

Furthermore, I agree to indemnify and hold harmless the City of Greer and its agents, servants and employees from all claims, actions, claims for relief, demands, rights, damages, costs, expenses (including attorney's fees), restitution and compensation, whether arising in equity, law or otherwise, which exists now or which may hereafter accrue to myself or any third party as a result of or in connection with my possession or use of any equipment or tools from The Neighborhood Tool Shed Program, including, but not limited to, any and all injuries, personal injuries, death and property damage and the consequences thereof, whether to myself or a third person, arising out of any cause whatsoever.

This Release and Indemnification agreement shall apply to myself, my heirs, personal representatives, successors, and assigns.

In the event this Release and Indemnification agreement is being signed on behalf of a Company or Organization, I hereby certify that I have authority to execute this Release and Indemnification Agreement on behalf of the Company or Organization, and the terms herein shall apply to the Organization, and its successors, assigns, employees, agents, and volunteers.
